

EITC Scholarships: Do I Qualify?

Tuition assistance is available to eligible students enrolled at Adams County Christian Academy. ACCA is committed to optimizing the funding available for tuition assistance and ensuring equitable distribution of these funds to eligible students. It is important for families to do their part by understanding the requirements of receiving tuition assistance.

In order to qualify for tuition assistance, the household annual income cannot exceed \$90,000 plus \$15,608 per dependent child as established by EITC law. For example:

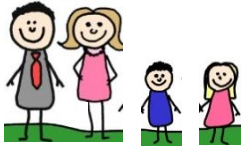
For a family with one child, you would qualify to receive tuition assistance if your household annual income, including the allowance per child, does not exceed \$105,608.



$$\$90,000 + \$15,608 = \$105,608$$

$$[\$90,000 \text{ (annual household income)} + \$15,608 \text{ (first dependent child)} = \$105,608]$$

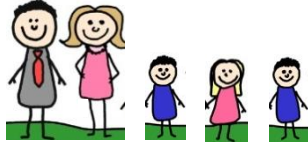
For a family with two children, the maximum income allowed would be \$121,216 per year:



$$\$90,000 + \$15,608 + \$15,608 = \$121,216$$

$$[\$90,000 \text{ (annual household income)} + \$15,608 \text{ (first dependent child)} + \$15,608 \text{ (second dependent child)} = \$121,216]$$

For a family with three children, the maximum income allowed would be \$131,824 per year:



$$\$90,000 + \$15,608 + \$15,608 + \$15,608 = \$131,824$$

$$[\$90,000 \text{ (annual household income)} + \$15,608 \text{ (first dependent child)} + \$15,608 \text{ (second dependent child)} + \$15,608 \text{ (third dependent child)} = \$131,824]$$

Additional qualifications are explained in the EITC Income Eligibility Guidelines document on our website.

ACCA has partnered with Central Pennsylvania Scholarship Fund for the tuition assistance application process. Every family seeking tuition assistance must apply by completing the application form and attaching the income verification documentation requested within the application. Applications can be obtained from our front office or requested via email (acca@adamscountychristian.org). All applications must be completed by the annual application deadline of June 25. Applications submitted after the deadline may not be eligible to receive EITC Scholarship funds for the current school year. Award notifications will be sent when determined, at which time your payment contract will be adjusted. No child can receive more than the maximum tuition cost in the form of assistance. *(There is no guaranteed tuition assistance regardless of income. Tuition assistance will be based upon assistance funds available.)* If you qualify for assistance, our current *minimum* awards are as follows:

Minimum Financial Assistance Awards possible for families earning:

\$90,001 and above.....	minimum of \$240.00 per child
\$60,001 - \$90,000	minimum of \$440.00 per child
\$45,001 – \$60,000	minimum of \$640.00 per child
\$30,001 – \$45,000.....	minimum of \$840.00 per child
\$30,000 and under.....	minimum of \$1040.00 per child
